



## **Wagnificent Waiver and Liability Release**

I agree to keep my dog's vaccinations up to date. \_\_\_\_\_

I trust that my dog will stay with the pack when off-leash. \_\_\_\_\_

Wagnificent agrees to exercise all due and reasonable care to prevent injury or death to my dog while hiking, however, I understand that potential harm is possible. I agree to release and hold harmless Wagnificent from all liability, including its independent contractors and employees, should my dog become lost, injured, or otherwise harmed while in Wagnificent's care. \_\_\_\_\_

I understand that fighting and/or biting is not tolerated at Wagnificent. If my dog bites a person or dog hard enough to require medical attention, I am responsible for paying vet bills and/or medical expenses resulting from said injury. I will indemnify, hold harmless and defend Wagnificent in the event of a claim or lawsuit by any person injured by my dog. \_\_\_\_\_

I acknowledge that this release is being relied upon by Wagnificent to permit transportation of my dog, to and from the town conservation land of Weston, MA, or any other necessary location (i.e a dog's residence or a veterinarian facility). I accept all known and unknown risks in allowing my dog to be transported. I release Wagnificent, its owner, and independent contractors from liabilities resulting in injury or death to my dog while being transported by Wagnificent. \_\_\_\_\_

Wagnificent will take precautions to prevent dogs from running away from vehicles or property, but I understand that dogs behavior can be unpredictable. I will not hold Wagnificent responsible if my dog finds a way to flee during transportation. Wagnificent can, at any time, refuse a dog transportation, if the dog exhibits behavior that might be harmful to himself and/or others (i.e aggression, uncooperative behavior, high fear, sickness). I will not hold Wagnificent responsible for any physical or mental issues that arise during or as a result of my dog being transported by Wagnificent, (i.e dog bites, minor cuts and scratches). \_\_\_\_\_

I understand that Wagnificent staff use their personal vehicles and homes to care for dogs. If my dog causes destruction of property by eliminating, chewing, etc., I may be expected to provide payment to replace and/or clean damaged property. \_\_\_\_\_

Understanding the risks stated above, I freely and voluntarily enter into this contract of permission with Wagnificent. This contract of permission is a full and complete instrument. No other warranties expressed or implied are valid unless stipulated above. I have read and understand the contents of this form. \_\_\_\_\_

This agreement shall be governed by, and construed in accordance with, the laws of the State of Massachusetts. I, the undersigned, affirm that I am at least 18 years of age and am freely signing this Waiver and Liability Release. I have read this Waiver and Liability Release and fully understand I am giving up legal rights and/or remedies which may otherwise be available to me regarding any losses I may sustain. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.
